

# Kiwi Shoe Aid for Africa Free Prize Draw Terms & Conditions

- I agree for Kiwi Shoe Aid for Africa to display my name, photo and message in the public domain.
- The Prize Draw is open to residents of the UK only aged 18 or over except employees and their families of Sara Lee/Kiwi, its agents or anyone professionally connected with the promotion.

- Incomplete or illegible entries or those not in accordance with the entry instruction will be rejected.
- Closing date for receipt of entries is 5th December 2010.
- One winner will be drawn at random under independent supervision will be notified by email within 28 days of the closing date. The Winner must claim their prize within 28 days of the notification. If the prize is unclaimed after this time, it will lapse and the Promoter reserves the right to offer the unclaimed prize to a substitute Winner selected in accordance with the Promotion rules selected at the same time as the original.
